REASON FOR RECOMMENDATION

As of October 2021, California Assembly Bill 640 authorized county child welfare agencies to re-determine a youth's eligibility for Title-IV-E at the time a youth enters Extended Foster Care (EFC) without any disruption to their services or support funding.

On Enter date of youth's 18th birthday, the youth, Youth's Name, will turn 18-years-old.

On Enter date, CSW CSW's Name discussed federal funding at re-entry with Youth's First Name. Based on this discussion, Youth's First Name consented to the Department filing a petition with the dependency court to dismiss dependency jurisdiction and immediately resume that jurisdiction in order to establish Youth's First Name's eligibility for federal financial participation. DCFS advised youth's counsel before obtaining youth's consent.

RECOMMENDATION

It is respectfully recommended:

- That a WIC 388(f) hearing be calendared immediately after Youth's First & Last Name eighteenth birthday to establish eligibility for federal financial participation.
